Version negative

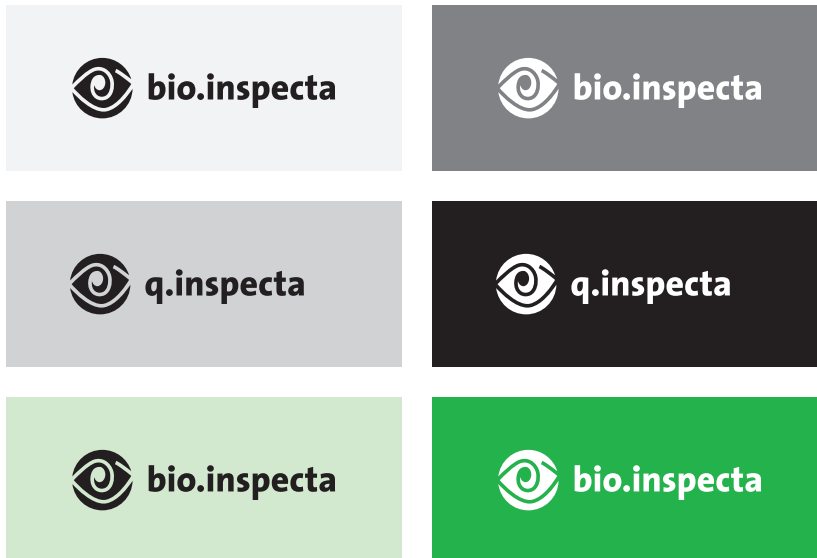
## 1.2 Application

### Coloured versions on white background



In principle, the use of the coloured versions on a white background is recommended.

### Black and negative versions



Where for technical reasons the coloured representation of the logos is impossible, the version black or (with dark background) negative can be used.

### 3. Labels and certification marks

#### 3.1 Principle

The respective certification mark can be used for the declaration of the certification body on the packaging and labels.

##### **A Labelling only with contractual relationship**

The certification / inspection label may only be used by companies that have a valid contractual relationship with bio.inspecta AG or q.inspecta GmbH.

##### **B Labelling only with valid certification**

Products bearing the label must also have valid certifications.

##### **C Labelling with certification mark**

## 3.2 Labelling types

Either the certification mark or plain text may be used for labelling.

### A Labelling with certification mark

We recommend the use of the certification mark for labelling on products.

### B Marking with text

If marking by means of a certification mark is not possible, this must be done with the number of the certification body. For the best possible customer information, we recommend the marking according to the example on the right.

#### Example

Organic certification:  
CH-BIO-006  
bio.inspecta AG  
CH-5070 Frick

### 3.3 Certification marks, colour versions

#### Standard version coloured on white background



In principle, the use of the coloured version on a white background is recommended.

#### Standard version on coloured background



With a coloured background, the certification mark is highlighted in white if possible.

#### Black and negative versions



Where for technical reasons the coloured representation of the certification marks is impossible, the version black or (with dark background) negative can be used.
